- The installation fee is determined from the sum of the design costs + contracted facilities configuration costs.
- The Design Expenses are 1250.00 pesos. It includes the planning and projection work, as well as the materials and resources used in the preparation stage of the project.
- The monthly fee applicable to the subscriber who contracts the service is determined from the fee per contracted facilities. As the duration is variable, the monthly closed cycle is considered for its calculation. Example: 15-day duration service, the month is billed and charged; if it lasts 1 month and 10 days, two (2) monthly fees are billed.
- The contracted facility configuration expenses describe the facility set selectable by the Entity subscribing to the service.



Modification fee:

It is a fee charged when requesting a modification for the contracted service conditions and is independent of the number of changes, activation or deactivation of facilities that are made.

In the case of a new facility, the new facility will be charged and the corresponding increase in the monthly fee will be made, according to the following table:
